Office Order

Bihar Skill Development Mission (BSDM) through the Recruit-Train-Deploy (RTD) scheme envisages to provide gainful employment opportunities to the youth of Bihar through placement linked skill training in association with the training providers of national and international repute. Deployment of candidates at suitable workplace is the ultimate objective. And therefore, there is a clause of recovery of training and related service charges from the training partners in case of non-placement of at least 80% of certified candidates from a batch.

M/s Prerna Engineering Education Group Private Limited had submitted a proposal to BSDM under RTD scheme. Letter of award (LoA) was issued vide letter no. BSDM/RFP-11/2018-1759, dated-22-12-2018 and MoU was signed on 05-03-2019 for a target of 320 Nos in 01 Job role for the districts of Patna, Gopalganj and Munger.

M/s Prerna Engineering Education Group Private Limited imparted training to 106 trainees in 04 batches between 01-07-2019 to 29-02-2020 as detailed below -

M/s Prerna Engineering Education Group Private Limited submitted a total number of 08 online invoices (No. of Approved Invoices: 04, No. of Invoice being processed:02, No. of deleted Invoices by TP: 02). BSDM had released the payment of INR 3,03,360/- against the first instalment


of batch Ids -5602,6231,7000 and 7097. There are 02 invoices which are under process for payment but during placement verification, it has been found that placement percentage is much less than 80% which is a mandatory condition as per the RTD RFP document.

M/s Prerna Engineering Education Group Private Limited was requested to provide necessary details pertaining to the placement of the batches through letter numbers BSDM/RTD-Payment-79/2019-278, dated 19-04-2021, BSDM/RTD-Payment-79/2019-322 dated- 01-06-2021. In response to the above letters, M/s Prerna Engineering Education Group Private Limited had requested four months of additional time to complete the placement gap through their email dated 26-07-2021. The request was approved and four months of time granted vide letter number BSDM/RTD-Payment-79/2019-520 dated-03-08-2021. After completion of 04 months, BSDM through its letter number BSDM/Payment-79/2019-80, dated-27-01-2022 sought necessary details pertaining to the placement of the batches within 07 days but no reply has so far been received. M/s Prerna Engineering Education Group Private Limited should have got back to BSDM, with placement update on their own but they failed to even respond to the reminder sent to them. It shows their wilful disregard to the concerns of the BSDM and the terms agreed into through the MoU.

M/s Prerna Engineering Education Group Private Limited is hereby ordered to pay back the entire amount paid to it against the first Instalment invoice of batch Ids- 5602,6231,7000 and 7097 which is INR 3,03,360/- within 21 days. The two invoices (second instalment) pending before BSDM for the two batches 5602 and 7097 also stand rejected for not meeting the placement norms.

This order is issued with the approval of the competent authority.


