Submission of proposals were invited through electronic mode only, and the bidder/s were to submit their Bid on e-Procurement platform at www.eproc2.bihar.gov.in.

In response to the above, it is reflected on E-proc 2 portal of Govt. of Bihar, that following **Five Chartered Accountant (CA) Firms** have submitted their proposal till the final stipulated time for uploading of offer/bid i.e. up to 03.00 P.M on 04th November 2024.

2. M/s. KRA & Co
3. M/s. P. Puneet and Co
4. M/s. Satendra Gupta and Associates
5. M/s. Thakur Bhuwanesh & Associates


The meeting of Technical Evaluation Committee was scheduled on 04th December 2024 wherein the technical documents of all the above bidders were accordingly evaluated against Minimum Eligibility Criteria of Notice Inviting Request for Proposal of the RFP and further technical evaluation against the Clause 8 (Technical Evaluation Score Matrix) of Section 2 of the RFP.


The Technical Bids of Two CA Firms viz (i) M/s. Komandoor & Co LLP and (ii) M/s. Satendra Gupta and Associates failed to pass the Minimum Eligibility Criteria and were thus rejected and not evaluated any further.

The Technical Bids of rest Three CA Firms viz (i) M/s. KRA & Co (ii) M/s. P. Puneet and Co and (iii) M/s. Thakur Bhuvanesh & Associates passed the technical evaluation and were recommended for opening of their financial bids and for further evaluation under Least Cost System (LCS) system as per "as per Clause 9.1" of the RFP document. The Financial Bids were accordingly opened in the meeting of Financial Evaluation Committee on 17th December 2024 and the bidders quoted (excluding GST, ref: clause 5.3 of the RFP) as below:
